

To all persons interested in the lands hereinafter described:

Whereas, pursuant to authority granted by Minnesota Statutes § 282.135, the Board of Hennepin County Commissioners has delegated its statutory authority, power, and responsibility for tax-forfeited land administration in Minnesota Statutes, Chapter 282, to the Hennepin County Administrator and the Hennepin County Auditor, by Resolution No. 95-8-556R1, adopted August 8, 1995. Whereas, pursuant to the application or request for change of status of tax forfeited land described more fully below, the County Auditor finds as follows:

That all parcels of tax forfeited land listed on Non-Conservation Appraisal List 2255-OA have been classified as non-conservation land; that the Appraised Value of each parcel on List 2255-OA be approved and authorization for a public sale of this land be granted, pursuant to Minnesota Statutes, Section 282.01; that the online auction will be open on December 2, 2024 at 8:00 a.m. and will close 11:59 pm on December 11, 2024, for not less than the Minimum Bid price (Appraised Value together with certified Specials after Forfeiture) as set forth on List 2255-OA; and that all sales shall be full payment or on the terms set forth on List 2255-OA, attached hereto and incorporated herein.
