- 3) REAC response to the killing of Daunte Wright
  A memo will be sent to County Commissioners and leadership with recommendations to
  - o Address the trauma of community at 66<sup>th</sup> and Humboldt and support through rent, mental health and other supports; develop a year long plan of support.
  - o Condemn attacks against peaceful protests and support 1st amendment right to protest
  - o Ban the use of non-lethal projectiles and chemical weapons use against protestors
  - o Support the police reform legislative efforts
  - Acknowledge that black mental health is deteriorating this is a result of racism's impact on public health

4) Hennepin County Engagement Strategy: Kelsey Dawson-Walton, Engagement Services Division Manager, Communication and Engagement Services

Information about the current county engagement strategies was provided. Members had questions about how performance is measured and improvements made, role of engagement in census and elections, how the Race Equity Impact Tool is being used in engagement and partnership with the community.

- Creating feedback loops via Survey 123, document who was engaged, how many contacted, information shared
- Census
  - Worked with Community Organizations to get Census information to communities
  - Census engagement specialists organized community events and targeted communities with low response counts
  - o Provided election information where to vote, how to register, etc.
  - o contracted with community organization, cultural groups and trusted individuals for feedback for improvement on what worked and what didn't
- REIT: Exploring how to use it to co-create with community organizations.

Pillsbury United Communities (PUC) Community Engagement Project information: Alisa Salewski; Chief Innovation Officer; and Vinodh Kutty, Senior Manager, Partnerships, Engagement and Initiatives, Center of Innovation and Excellence.

PUC received funding from the Kresge foundation and the county is partnering with PUC to enhance community engagement.

Members had questions about how the county will support PUC after the 3 year grant, how REAC will be informed about community input, priorities and solutions.

- The partnership is in its early stages. PUC and the County leadership are exploring ways to continue the partnership; nothing is concrete or decided
- PUC and County are working together to ensure diversity in residents who are being engaged.

- 5) American Rescue Plan Act of 2021 memo to County Comissioners and Administration.

Hennepin County has been allocated \$240 million from the American Rescue Plan Act of 2021 (ARP) and members wanted to provide community input proactively. Since this funding is for mitigating the effects of the pandemic, suggestions have been framed with a racism as a public health crisis lens. These ideas came from the committees at their meetings. The ideas will be sent to County Commissioners and County Administrators in a memo.
