- 4) Commissioner Lunde introduced himself and in response to questions from members spoke about:
 - a. Currently working on eviction moratorium
 - b. Metro Blue Line extension: Has been working with Commissioner Fernando and been very vocal to Met Council. Robbinsdale and North Minneapolis are concerned about the route's impact on their communities so the engagement process needs to give voice to and address their concerns.

Racial equity priorities for the county are:

- a. inequities in health system: need to improve vaccination rates for indigenous and black communities. There are efforts through Hennepin Health and North Memorial to take vaccines to the community and people in hi-rises.
- b. Plan for criminal justice reform: review data so solutions are targeted to groups that need help most to get out of jail.
